Provides direct client/patient care in accordance with established care plan; assists with personal hygiene (e.g. bathing, shampooing, foot care, nail care); provides health screenings by taking vital signs (e.g. blood pressure, respiration, weight, height, accu-check, temperature, etc): checks and/or cleans wounds, dress wounds, reviews with client/patient and/or family members the direction of taking prescribed and/or over-the-counter medications; checks for client/patients scheduled appointments; arranges for transportation if necessary; assists with range of motion exercises; provides transition for client/patient, as needed. Maintains records of observation, progress, activities and other pertinent information utilizing the patient care component and Subject, Objective, Assessment and Plan (SOAP) format. Maintains daily log of activities, interprets for clients, maintain confidentiality, development care plan, performs charts reviews, conduct health screening at health fair. Attends chapter meetings, in-service training. Assist with emergency situations as needed.

One (1) year experience providing non professional nursing care and home health care to elderly, homebound, or other patients needing assisted living services in their home; or an equivalent combination of education, training, and experience which provides the capabilities to perform the described duties. **(to receive full credit for education/training applicant must submit copies of college transcript, certificates, diploma, etc.)**
