DUTIES AND RESPONSIBILITIES:

Drive bus to transport nine to twenty-five passengers to specified locations; comply with traffic regulations; perform daily routine bus inspections, maintenance and repairs; report delays in accidents; maintain trip log by recording travel, fuel and maintenance expenses; maintain discipline, safety and comfort of passengers; direct loading and unloading of passengers; may conduct and participate in bus safety drills and presentations; attend meetings, prepare and submit required reports; maybe required to participate in classroom instructions, provide assistance in the supervision of children and assist with the preparation of meals based on Head Start program guidelines.

Knowledge of the methods, practices, tools, equipment, and materials used in the operation and maintenance of automotive vehicles; knowledge of the occupational hazards and safety precautions necessary to minimize injury to passengers or damage to equipment; knowledge of traffic codes and regulations; ability to locate the cause of vehicle malfunctions; ability to understand and communicate in both English and Navajo languages. Work requires lifting up to 50 lbs, and caring and working with young children. **(To receive full credit for education and/or experience, submit copies of diplomas, degrees, transcripts, certificates, etc.)**

License/Certification Requirements:

Must pass a criminal background check and employee assessment prior to employment; Within 90 days of employment must obtain a Bus Drivers Certificate, a Navajo Nation Operator's Permit, a current Cardiopulmonary Resuscitation (CPR) Certificate, a First Aid Certificate and a Food Handler's Permit.
